TERMS AND CONDITIONS

All entry forms must be returned to the Secretary of the Section for which you propose to enter (see over) by no later than Friday, 20th June, 2025.

Please note that entry to the Rally site cannot be guaranteed unless you have completed an entry form and returned it to the appropriate Secretary and received your Exhibitor's Pass – PLEASE DISPLAY THE ENTRY PASS IN YOUR WINDSCREEN to help Rally Staff.

By returning this form to the appropriate Section Secretary you acknowledge and accept:-

(a) That you will have driving licence and insurance appropriate to the vehicle or machine being shown by the Exhibitor and a minimum cover of 2 million pounds shall be in force and proof of this may be asked for together with any policy or certification appropriate to the machine you are bringing.

(b) That the Rally organisers of the event have taken reasonable precautions to ensure the health & safety of everyone present and for these measures to be effective and to avoid and prevent accidents occurring you MUST obey the instructions of the organisers and all the Rally officials and stewards.

(c) That you accept liability for any accident or injury to persons or loss of damage to vehicles, exhibits or property caused by you or attributable to you whilst occupying or using any part of the site and will not hold the organisers or the land owners responsible.

(d) That the unloading and loading of exhibits (especially tractors and heavy machinery) and any refuelling of exhibits will be undertaken only in the roped off areas set out for that purpose.

(e) Please note that the gates open at 8.00am and exhibitors expected to have checked in by no later than 10.30am. The Rally organisers would appreciate (for the benefit of paying visitors) if exhibits remained on site until at least 4.00pm (unless by prior arrangement with the Section Secretary).

RULES FOR THE RALLY FIELD

1. For insurance purposes the Rally site is treated as if it is a public highway and accordingly no underage driving is permitted and only ONE person is allowed on a tractor or motorcycle unless a second seat is provided by the manufacturer as original equipment and no dogs or other pets shall be carried on tractors or motor bikes.
2. A speed limit of 4mph (walking speed) applies throughout the site. There should be no vehicle movements apart from exhibits. If you need to leave the site it must be before 10.00am and if you return you MUST park in the public car park until after 5.00pm.
3. Beware of unaccompanied children on site when driving to and from the main ring. Dogs must be kept under control and kept on a leash at all times.
4. Please do not put hot remains of barbecues in the wheelie bins in the camp field. NO camp fires permitted.
5. Working equipment is present on site and accordingly children MUST be kept under supervision and away from such equipment. Working machinery should not be left unattended.
6. The organisers reserve the right to require you to produce your driving licence and insurance details to the Safety Officer or your Section Secretary.
